Recipient Spotlight - Brent Adams

Within loss you find grief and with grief you discover things about yourself and your family that you had never known before and would never know hadn't something so tragic change you.

We are a family of four with a beautiful daughter and big sister, Lila who is 7 years old. Our youngest, our son Brent, Jr., who is now our soulful angel in heaven, whom we lost at the young age of 19 months about a year and half ago. Brent, Jr. was one of a kind medically speaking and spirit wise. He was born with a congenital heart condition, Truncus Arteriosis Type I, a narrow airway which caused him to have a tracheostomy as his critical airway, and a rare genetic disorder called Complete DiGeorge Syndrome where he completely lacked T cells, an important part of your functioning immune system. He made it through 3 open heart surgeries and we all had high hopes that Brent would receive a thymus transplant at Duke University to give him a new immune system. Despite all those obstacles he had so many happy days, he had a passion for music of all kinds, loved to listen to poetry and of course Mickey Mouse and his big sister were the brightest part of his day.

We spent more than half of his life in the hospital, my husband was on FMLA leave which he ended up exhausting and his company gave him additional time off. None of that time was paid time off including the FMLA leave. I was a paralegal for many years' prior but had to leave my job once our son was born and we went from having two full time incomes to having no income at all. When your life falls to shambles and everything good seems to slip away, the life of bills and responsibilities still goes on and you're still responsible for making those monthly payments. That is how we were introduced to the Automotive Aftermarket Charitable Foundation, through a co-worker of my husband. His co-worker was researching and calling everyone he could think of to find help to give us that little bit of relief that we so very much needed. We felt not just overwhelmed with getting bad news on top of bad news about our son's health but worrying about how we were going to make our monthly payments were taking a toll on us.

Since the first moment that we spoke to AACF we had a huge weight lifted from our already heavy hearts with knowing that we weren't going to have to stress and worry about how we were going to pay our bills. The relief really allowed us to be 100% committed to our son in the hospital and also to our daughter, who was 5 years old at the time and just started Kindergarten. Juggling the two children was hard, my husband was the one who mostly stayed at home and cared for our daughter and I stayed in the hospital trying to understand and stay on top of our sons complicated health. The help that was provided to us from your foundation allowed us to be our sons primary caregivers and we were told several times by his doctors that it was because of our care and our close attention to details that gave us the additional precious time with our son, especially the time spent at home with his big sister. Our time with him was the greatest blessing, a treasure that we all 3 keep close to our hearts. It was filled with memories that we will never forget of time that we can never get back.

Our son was a happy soul who made the best of the life that he was given. We watched him everyday beat the odds and learned so much from him about life, family and unconditional love. We would trade in all the wisdom and perspective that we've gained from this journey to have our son back in our arms but it's the gift of loss in which he has given us and we mean to do something helpful with it. I began my career with extensive field sales experience and increasing management roles at Tenneco Automotive. I then became marketing director, FleetPride, where I developed and executed a strategic marketing plan integrating 37 separately-owned companies into what is now the largest independent heavy duty parts distributor.

The next step in my career was as VP, marketing, Dorman Products, Inc., leading creative and data services, trade marketing and product communications, doubling sales of "OE dealer exclusive" parts, automotive hardware and brake parts sold under the Dorman brand. I then became VP, sales and marketing, Schaeffler Group USA, leading the North American aftermarket team while developing and implementing a new company strategic direction, transitioning its sales and product focus from co-man to direct sales.

I take great pride and satisfaction in serving on the board of the Automotive Aftermarket Charitable Foundation. I have had the occasion to recommend AACF assistance for colleagues who found themselves in unfortunate situations and difficult times and you never know when you might need a helping hand. Our industry is more than just selling parts and keeping motorists on the road, we are a community that cares for our own. Recipient Spotlight Continued

I found my life's passion in caring for him and I'm now in the process of applying to nursing school to obtain my RN degree. I want to help children just like our son and support parents just like us who have lost a child.

After our son passed away we all suffered from obvious reasons. Heart break is not something that you can just cure and my husband took FMLA leave again as we tried to heal our broken hearts. Those months afterwards were a blur but the foundation supported us through it and gave us time to grieve and be there for our daughter. About 4 months after our loss we decided we really needed to get out of the house where all our memories were with our son and with help from our family we bought our first home. My husband went back to work full time after his leave and I started school full time, which doesn't allow me to return to work especially when I start the nursing program in January 2017. About 4 months after we bought our house my husband suffered a grand mal seizure from a low potassium level which put him in the hospital and required many appointments and tests with the neurologist. He healed from that and about a month later our daughter broke her tibia and was in a wheelchair with a full leg cast for the holidays and the next couple of months. More recently the doctors found a bone spur on my husband's cervical vertebrae and narrowing of his spinal canal which caused him to lose ability to use his last two fingers on his left hand. The feeling has started to come back in his hand but it was something that came out of nowhere and the doctors are still trying to get more information about it and how to fix it; either with spinal injections or spinal surgery if necessary. Through all of our times of struggle though, the AACF has been by our side assisting us so we can continue to heal.

It's been a long journey and it's taken a lot of reflecting, struggle and tears to get to where we are now, and we still have a long way to go. The Foundation gave us hope at a time in need and still continues to give us hope and prove to us that there are people out there that do care and want to help especially in times when it's hard to ask for it. We are forever grateful for the foundation's support and know that it is because of that support we're able to try and rebuild our lives.
